### **Extended Supplies of Medication Under NC Medicaid:**

We would like to remind our providers that Medicaid beneficiaries, including our WellCare of North Carolina members, are eligible to obtain a 90-day supply of non-controlled, maintenance medications if the prescriber issues a prescription for that duration.

An exception to this is oral birth control medications, which can be dispensed as a full 12-month supply if prescribed accordingly. Please note that certain medications, such as short-term antibiotics and topical steroids, are typically not eligible for a 90-day supply.

Prescribing a 90-day supply for your patients not only offers convenience but

also saves them money, as only one copay (if applicable) is charged for the entire 90-day supply.
